### PERSONAL DATA THAT WE PROCESS

Crunch & Huntening processes your personal data because you use our services and/or because you provide this data to us yourself. Below you will find an overview of the personal data that we process:

- First and last name
- Address data
- Phone number
- E-mail address
- IP address (anonymised)
- Other personal data that you actively provide, such as your organization
- Information about your activities on our website
- Data about your surfing behavior across our website
- Internet browser and device type
- Bank account number

#### SPECIAL AND/OR SENSITIVE PERSONAL DATA THAT WE PROCESS -

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years old. Unless they have parental or guardian permission. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us at info@crunch-huntening.com and we will delete this information as soon as possible, and at the latest within four weeks.

#### FOR WHAT PURPOSE AND ON WHAT BASIS WE PROCESS PERSONAL DATA-

Crunch & Huntening processes your personal data for the following purposes:

- To handle payments and invoicing
- To be able to call or e-mail you if this is necessary to be able to carry out our services
- Inform you about changes to our services and products
- To deliver goods and services to you
- Crunch & Huntening analyzes your behavior on the website to improve the website and to tailor the range of products and services to your preferences.
- Crunch & Huntening also processes personal data if we are legally obliged to do so, such as data that we need for our tax return



### HOW LONG WE KEEP PERSONAL DATA -

Crunch & Huntening does not store your personal data longer than is strictly necessary to realize the purposes for which your data is collected. However, we use a retention period of 7 years for the following data, driven by our legal obligation according to Dutch tax requirements:

- First and last name
- Address data
- Phone number
- E-mail address
- Other personal data that you actively provide to us
- Bank details

#### SHARING PERSONAL DATA WITH THIRD PARTIES

Crunch & Huntening does not sell your data to third parties and will only provide data if this is necessary for the execution of the agreement between you and Crunch & Huntening or to comply with any legal obligations. If a third party is required to provide data, Crunch & Huntening remains responsible to maintain and manage the processing operations in accordance with the Privacy statement, unless a compliance agreement between Crunch & Huntening and third parties are explicitly made and formalized.

#### COOKIES, OR SIMILAR TECHNIQUES, THAT WE USE

Crunch & Huntening uses functional, analytical, and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet, or smartphone when you first visit this website. Crunch & Huntening uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings may be remembered. Cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that keep track of your surfing behavior so that we may offer customized content.

On your first visit to our website, we already informed you about these cookies and we asked for your permission to place them.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously stored via the settings of your browser.

### VIEWING, CORRECTING, OR DELETING DATA

You have the right to view, correct or delete your personal data. You can do this yourself via the personal settings of your internet account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability (Dutch: gegevensoverdraagbaarheid). This means that you can submit a request to us to send you the personal data we have about you in a computer file.

If you want to make use of your right to object and/or right to data portability or if you have other questions/remarks about our data processing, please send a specified request to info@crunch-huntening.com.

To ensure that the request for access has been made by you, we do ask you to enclose a copy of your proof of identity with the request. Attach your passport photo, where MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Social ID number (Dutch: BSN nummer) are blacked-out. This is to protect your privacy. Crunch & Huntening will respond to your request as soon as possible, and at the latest within four weeks. We would also like to point out that you have the right to file a
